Board members in attendance included Cindi Mansell, Sherry Poll, Nate Reeve, and Darren Hess. Jan Ukena was excused. Maintenance: Freddy Loertscher, and Wayne Stark were present.

Minutes approval from the August 10, 2022, board meeting

Mr. Reeve moved to approve the August 10, 2022 minutes as written. Seconded by Ms. Poll. Motion carried.

Maintenance Report and Business

-Mr. Loertscher reported on visits to customers with higher water usage. The issues have been addressed and the customers were compliant with requests to correct their water use. -The main padlock to the District office entrance gate was moved and another padlock was put on the gate in it's place. The new padlock had to be cut off so maintenance could enter. It was not discovered who placed the new lock on the gate.

Mr. Reeve recommended getting new locks and keys for the gate as well having the building and office doors rekeyed. Only the maintenance team and the office staff should have a key to the reservoir. Maintenance will take care of this assignment.

Mr. Lorerscher and Mr. Stark were excused.

ARPA Grant Funding / Bond Update

A public hearing will be set to discuss the ARPA grant funding and bond consideration.

Ms. Poll moved to set a public hearing for bond consideration on October 12, 2022, at 6:00 p.m. Motion seconded by Mr. Reeve. Motion carried unanimous.
