Minutes for the South Weber Water Improvement District Board Meeting held Wednesday, December 1, 2021, at 6:00 p.m. in the Water District Building. Board members in attendance included Darren Hess, Jan Ukena, Perry McCorkle, Nate Reeve and Cindi Mansell.

Public Hearing - 2021 Budget Amendments and 2022 Budget Plan

Ms. Mansell moved to open the Public Hearing on the Budget. Motion seconded by Ms. Ukena Motion Carried.

No public comments made.

Ms. Mansell moved to close the Public Hearing. Seconded by Ms. Ukena. Motion Carried.

Mr. Reeve moved to approve the 2021 amended budget as discussed. Seconded by Ms. Mansell. Motion Carried.

Mr. Reeve moved to approve the 2022 budget as presented of \$499,123 with Ms. Dahl adding actuals of Weber Basin contract numbers. Seconded by Ms. Mansell. Motion Carried.

Minutes approval from the November 16, 2021, board meeting

Ms. Mansell moved to approve the November 16, 2021 minutes as written. Seconded by Ms. Ukena. Motion carried.

Maintenance Report and Business

- -Mr. Stark was excused as he was ill.
- -Mr. Loertscher reported on a repair needed at the Peek's property near the 4-inch valve at the end the District line. When the contractors dug it up there was an old 4x6 block of cement that had been holding the valve so that it wouldn't blow out with the high pressure. The contractors dug the old cement out and poured about a 1/4 yard of new cement to fix the problem.
- -Report on the installation of a new heavy duty garage door opener on the East outside door of the District building. A new keypad was also installed.

-Mr. Loertscher and Mr. McCorkle located the last old air valve on the system and marked it with flags so it can be replaced in the spring before the water is turned on.

Mr. Loertscher was excused.

Maintenance Contract Review

Discussion of maintenance contract renewal.

Ms. Ukena moved to approve the renewal contract with Kastlerock Excavation & Development LLC if the contractor agrees. Seconded by Ms. Mansell. Motion carried.
